NOTICE IS HEREBY GIVEN that the Annual Stockholders' Meeting of **HOUSE OF INVESTMENTS, INC.** will be held on **Friday, August 14, 2026 at 4:00 P. M.**, with proceedings livestreamed and voting conducted via remote communication or *in absentia* through the Company's secure online voting facility.

Pursuant to the alternative mode of distributing and providing copies of the notice of the Annual Stockholders' Meeting as provided for in the Securities and Exchange Commission's NOTICE dated March 11, 2026, this notice to Stockholders shall be published in the business section of two (2) newspapers of general circulation, in print and online format, for two (2) consecutive days beginning July 15, 2026. Electronic copies of the Information Statement, Management Report, SEC Form 17-A and other pertinent documents will be made available on the (a) Company's website (www.hoi.com.ph) and (b) PSE Edge.

Stockholders may only attend and participate in the meeting by remote communication and vote only by proxy or remotely *in absentia*. Stockholders who wish to attend and participate in the meeting by remote communication shall inform and notify the Company by email at hi_asm@hoi.com.ph, on or before August 4, 2026. The link to the live webcast of the meeting shall be sent to the email address of the registered stockholder.

For voting via Proxy, duly accomplished proxies shall be submitted by email to the Office of the Corporate Secretary at hi_asm@hoi.com.ph, for inspection, validation, and recording at least ten (10) days before the Annual Stockholders' Meeting or on or before August 4, 2026. Proxies received thereafter shall not be recognized for the meeting. The validation of ballots and proxies shall be held on August 5, 2026, 3:00 P.M., at House of Investments, Inc.'s office at the 27th Floor The Yuchengco Centre Building 333 Sen. Gil J. Puyat Avenue Makati City.

The details of the procedures for attending and participating in the meeting through remote communication, casting of votes and the proxy form format are set forth in the Information Statement.

The Company shall record the Annual Stockholders' Meeting and post the same in its website.
